Pursuant to our conversation on April 27, 2000 Teleglobe Business Solutions Inc. ("TBS") hereby submits this letter to clarify information in regard to the name change of Telco Holdings, Inc. d/b/a Dial & Save to Teleglobe Business Solutions Inc. and to request that the TRA correct the Order and issued on April 11, 2000 in the above referenced case and any other pertinent records to reflect the following:

- The above-referenced name change is from Telco Holdings, Inc. d/b/a Dial & Save to Teleglobe Business Solutions Inc. (The order erroneously listed the new name as Teleglobe Communications Corporation d/b/a USA Quick Phone).
- 2. Teleglobe Communications Corporation ("TCC") is a holding company affiliated with the Applicant. TCC DOES NOT hold a Certificate of Public Convenience and Necessity to provide telecommunications service in Tennessee. We can only speculate that the confusion may have occurred because of Teleglobe USA Inc., a sister company of the Applicant. Please note that Telegiobe Business Solutions Inc. (the Applicant), Telegiobe Communications Corporation (a holding company affiliated with the Applicant); and Teleglobe USA Inc (Applicant's affiliated company, licensed in Tennessee) are all SEPARATE companies.
- 3. We do not have any knowledge of the name "USA Quick Phone".

By way of background, THI is authorized to provide intrastate interexchange and local exchange telecommunications services in Tennessee pursuant to the TRA Order in Case Nos. 95-02455 (June 15, 1995) and 96-00982 (August 14, 1996), respectively. Including Tennessee, THI is authorized to provide resold intrastate interexchange telecommunications services in forty-eight (48) states and intrastate local exchange telecommunications services in twenty-seven (27) states, pursuant to certification, registration, or, where applicable, deregulation. THI also holds an international Section 214 authorization to provide global facilities-based and global resale telecommunications services to all international points.<sup>1</sup>

THI has determined that the name change from Telco Holdings, Inc. to Teleglobe Business Solutions Inc. will be a valuable step in developing its telecommunications services and in implementing its ongoing business plan. Specifically, the name change will facilitate consolidation of business customers under a single brand name in the Teleglobe corporate family of telecommunications service providers, thereby strengthening the Company's position in the telecommunications market and increasing the efficiency of operations through economies of scope and scale. The name change will not in any way inconvenience or cause harm to THI's customers.
