Pursuant to our conversation on April 27, 2000 Tele globe Business Solutions Inc. ("TBS") hereby submits this letter to clarify information in regard to the name change of Telco Holdings, Inc. d/b/a Dial & Save to Tele globe Business Solutions Inc. and to request that the TRA correct the Order and issued on April 11, 2000 in the above referenced case and any other pertinent records to reflect the following:


1. The above-referenced name change is from Telco Holdings, Inc. d/b/a Dial & Save to Tele globe Business Solutions Inc. (The order erroneously listed the new name as Tele globe Communications Corporation d/b/a USA Quick Phone).
2. Tele globe Communications Corporation ("TCC") is a holding company affiliated with the Applicant. TCC DOES NOT hold a Certificate of Public Convenience and Necessity to provide telecommunications service in Tennessee. We can only speculate that the confusion may have occurred because of Tele globe USA Inc., a sister company of the Applicant. Please note that Tele globe Business Solutions Inc. (the Applicant), Tele globe Communications Corporation (a holding company affiliated with the Applicant), and Tele globe USA Inc (Applicant's affiliated company, licensed in Tennessee) are all SEPARATE companies.
3. We do not have any knowledge of the name "USA Quick Phone".




