
--CORRECTED ORDER--

IT IS THEREFORE ORDERED:


1. That the petition of Frontier Communications Services Inc. to change its name to Global Crossing Telecommunications, Inc. is approved.

On January 7, 2000, and again on April 18, Frontier Communications Services Inc. (Company I.D. 000026) notified the Tennessee Regulatory Authority ("TRA") that we had commenced doing business under the name **Global Crossing Telecommunications, Inc.** A copy of our April 18 letter is enclosed for your reference. Today we received a copy of a May 9, 2000 TRA Order in the above-referenced Case. Unfortunately, this Order erroneously lists our affiliate, Frontier Telemanagement Inc., as the entity whose name change to Global Crossing Telecommunications, Inc. has been approved. A copy of this Order is also attached herein.

If you review the attached copy of another TRA Order issued December 7, 1999 (Case No. 99-00877), you will note that the TRA previously and correctly approved a name change for Frontier Telemanagement Inc. (Company I.D. 128058) to Global Crossing Telemanagement, Inc.




