

This Hearing will be conducted in accordance with the Tennessee Uniform Administrative Procedures Act, T.C.A. §4-5-101 *et seq.* All parties are entitled to be represented by counsel.

This Hearing is scheduled for the purpose of hearing testimony regarding United Cities Gas Company's request for approval of franchise agreements with the Cities of Kingsport, Bristol, and Morristown, Tennessee, and Maury County, Tennessee. All parties are hereby directed to file pre-filed testimony of all witnesses who will testify regarding the requests for approval of the franchise agreements. All pre-filed testimony shall be filed with the Executive Secretary's Office no later than **2:00 p.m. on Tuesday, March 12, 2002.**
