**Re: Request to Surrender the Certificate of American Fiber Systems, Inc.**

Dear Chairman Allison:

On behalf of Zayo Group, LLC ("Zayo"), as the successor in interest to American Fiber Systems, Inc. ("AFS"), this letter voluntarily surrenders the Certificate issued in Docket No. 00-00988 to AFS (the "Certificate"). Zayo requests that the Authority cancel the Certificate granted to AFS and withdraw all tariffs on file with the Authority. Further, in the event that AFS has a current bond or letter of credit on file with the Authority, Zayo requests that the Authority authorize the cancellation of the bond or letter of credit and return it to Zayo.

As described more fully in Docket No. 13-00019, AFS and its parent companies merged with and into Zayo, with Zayo surviving the mergers. The mergers were completed on March 12, 2013 and, as a result, AFS no longer exists as a separate corporate entity and Zayo provides telecommunications to its customers pursuant to Zayo's certificate issued in Docket No. 11-00116. Since AFS no longer exists and Zayo provides services to their customers, the Certificate of AFS should be cancelled effective March 12, 2013 or as soon as the Authority can take any appropriate administrative action.
