**Re: IDS Telecom Corp. and Now Communications, Inc.
Request to Surrender Authorization to Provide Intrastate
Telecommunications Services**

Dear Ms. Dillon:

IDS Telecom Corp. d/b/a Cleartel Telecommunications ("IDS") and NOW Communications, Inc. d/b/a Cleartel Telecommunications ("NOW"), request that the Tennessee Regulatory Authority ("TRA") cancel their authority granted by, and rescind all tariffs on file with, the TRA to provide local exchange and interexchange telecommunication services, effective immediately. IDS and NOW also request that their Letters of Credit Numbers 68005535 and 7413201, be cancelled and returned in accordance with the Commission's acknowledgment, acceptance and subsequent approval of this request.

In Tennessee, IDS holds authority to provide local exchange and interexchange telecommunications services granted in Docket No. 05-00048 on June 30, 2005. NOW holds authority to provide local exchange and interexchange telecommunications services granted in Docket No. 03-00455 on February 19, 2004. IDS and NOW, however, no longer provide telecommunications services in Tennessee following the completion of the migration of IDS and NOW's customers to Birch Communications on August 25, 2009.¹ IDS and NOW, therefore, no longer require their authorizations and are in the process of winding their business down and dissolving, which IDS and NOW intend to complete by mid-December 2009. Because IDS and NOW do not serve any customers or have any active operations in Tennessee, IDS and NOW respectfully submit that the surrender of their authorizations and withdrawal of their tariffs is reasonable and necessary and will not be disruptive to the present or future public interest, convenience and necessity.

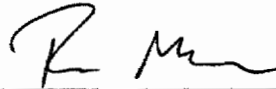

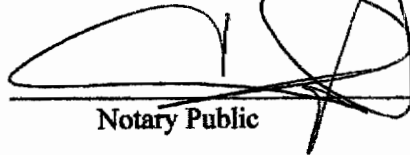
