The Tennessee Regulatory Authority is in receipt of the above application for authority to provide resold interexchange telecommunications services in Tennessee. In order to continue processing the application, please provide the following information:

- 1) Part 1(A) and Exhibit A to the application indicates that STi Prepaid, LLC has also registered the assumed names "Telco Group," "Dialaround," "VOIP Enterprises," and "VOIP." Is STi Prepaid also seeking authority to resell telecommunications services in Tennessee using these assumed names?
- 2) How will STi market its services in Tennessee? Will the terms and conditions be set forth in the same language as the advertisement?
- 3) Are there currently any ongoing investigations into STi's advertisements, fees, service charges and/or marketing regarding its prepaid calling cards? If so, please identify the agency or department conducting the investigation and explain STi's response to the allegations.
- 4) The financial information submitted with STi's application was for the ultimate majority owner, Leucadia National Corporation. Does STi have audited or unaudited financials for the business operations ongoing in the states where it is currently operating? If so, please provide the most recent financial information, including balance sheet and income statement, for STi Prepaid, LLC. If STi Prepaid, LLC will be relying on its majority owner for funding, please provide a sworn statement from Leucadia National Corporation indicating its willingness to provide funding, if necessary, for STi Prepaid, LLC's operations in Tennessee.

It is requested that this information be provided no later than 2:00 pm on August 31, 2007 and that you reference Docket Number 07-00191 on the response. In accordance with TRA rules submit either (1) thirteen written copies of your response or (2) four written copies and an electronic version.
