Setting a procedural schedule to completion, including a discussion of consolidating this Docket with Docket No. 99-00909, *Application of Memphis Networx, LLC for a Certificate of Public Convenience and Necessity to Provide Intrastate Telecommunications Services and Joint Petition of Memphis Light Gas & Water, a Division of the City of Memphis, Tennessee ("MLGW") and A&L Networks-Tennessee LLC. ("A&L") for Approval of Agreement Between MLGW and A&L Regarding Joint Ownership of Memphis Networx, LLC;* and
4. Considering the filing of stipulations/admissions of facts and documents.

Any party desiring to participate in this Pre-Hearing Conference must file a Petition to Intervene no later than **Friday, February 23, 2001**, as set forth in the February 16, 2001 Notice. Petitions to Intervene filed by that date will be considered at the Pre-Hearing Conference.

Any motion to change the date of this Pre-Hearing Conference must be made in writing and filed with the office of the Executive Secretary of the Authority no later than five (5) days before the date of the Pre-Hearing Conference. Copies of the motion must be served on all parties. All parties are entitled to be represented by counsel.
