A13.90.4 BellSouth® Primary Rate ISDN Voice/Data Program

A. Rules and Regulations

Beginning March 22, 2001 and continuing until June 22, 2001, qualifying customers may enroll in this Program, which provides discounts on their billed monthly charges on BellSouth® Primary Rate ISDN as described below, by signing a twoyear or three-year term contract.

- In order to qualify for the Business Discount Program for Voice/Data Primary Rate ISDN, new and existing BellSouth business customers agree to maintain at least 4 BellSouth® Primary Rate ISDN circuits.
- Existing BellSouth® Primary Rate ISDN customers whose tariff or Contract Service Arrangement (CSA) term plan has more than six months remaining before expiration may not enroll in this program. Applicable termination liability charges will be waived for qualified existing BellSouth® Primary Rate ISDN customers who terminate a tariff or CSA term plan and enroll in this program with the same service provided under that term plan.
- Qualifying Program participants must sign a term contract of two or three years to receive the B-Channel monthly recurring rates that are detailed in B. following. Other Primary Rate ISDN rate elements required for service will be billed at rates as stated in A42.3.4 of this Tariff.
- To participate in this Program, qualifying customers must sign a two or three year term contract between March 22, 2001 and June 22, 2001. Following this period, no subscribers may enroll in this Program. This Program is available for resale for the duration of this enrollment period. Following the expiration of this enrollment period, no new customers may enroll in the Program, but any contract established under this Program between BellSouth and its customers would continue to be available for resale for the remaining term of the existing contract. Aside from these resale situations, a customer may not assign its rights under any contract signed pursuant to this Program to another customer or to any other third party.
- Should a participating customer terminate a contract signed under this Program without cause, charges for termination or cancellation of service shall not exceed the lesser of: (a) the sum of the repayment of discounts received during the previous 12 months of the service and the repayment of the prorated amount of any waived or discounted non-recurring charges; or (b) six percent (6%) of the total contract amount.
- New Voice/Data Primary Rate ISDN service enrolled in this program must be installed by August 22, 2001.
- Customer revenue associated with this program is not eligible for additional discounts under any other BellSouth program or CSA, including Volume and Term contracts.
- Program rates may be applied up to a maximum of 20 Voice/Data Primary Rate ISDN circuits.
