Re: Request to Surrender the Certificate of USCarrier Telecom, LLC

Dear Chairman Allison:

On behalf of Zayo Group, LLC ("Zayo"), as the successor in interest to USCarrier Telecom, LLC ("USCarrier"), this letter voluntarily surrenders the Certificate issued in Docket No. 01-00512 to USCarrier (the "Certificate"). Zayo requests that the Authority cancel the Certificate granted to USCarrier and withdraw any tariffs on file with the Authority. Further, in the event that USCarrier has a current bond or letter of credit on file with the Authority, Zayo requests that the Authority authorize the cancellation of the bond or letter of credit and return it to Zayo.

As described more fully in Docket No. 13-00076, USCarrier and its parent company merged with and into Zayo, with Zayo surviving the mergers. The mergers were completed on June 21, 2013 and, as a result, USCarrier no longer exists as a separate corporate entity and Zayo provides telecommunications to its customers pursuant to Zayo's certificate issued in Docket No. 11-00116. Since USCarrier no longer exists and Zayo provides services to their customers, the Certificate of USCarrier should be cancelled effective June 21, 2013 or as soon as the Authority can take any appropriate administrative action.
