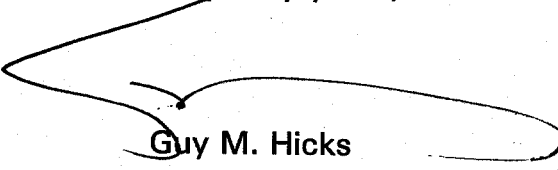

MOTION TO CONVENE MEDIATION CONFERENCE

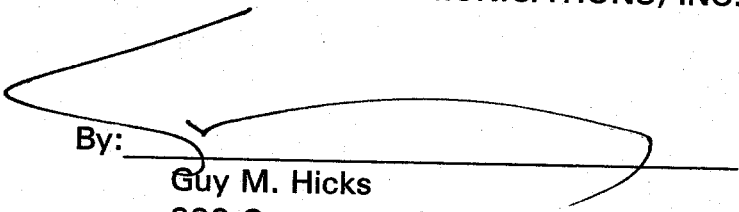
BellSouth recognizes that the Authority would like to resolve these complaints within 60 days of the dates on which they were filed. That would require resolution of the complaints by December 8, 2001. The parties have recently received a very aggressive procedural schedule from the Hearing Officer which includes hearing dates during the week of December 3, 2001, the same week of the OSS hearings in Docket No. 01-00362.

BellSouth too would like to resolve these complaints expeditiously. BellSouth would like to resolve these matters by negotiated agreement. Because there will be four different groups involved in the process, Access Integrated Networks, Inc., XO of Tennessee, Inc., the Authority, and the Consumer Advocate Division of the Attorney General's Office, rather than attempt piecemeal settlement negotiations, BellSouth believes the most likely avenue for resolving the matter within 60 days would be for the Hearing Officer to convene a mediation conference at which all parties could discuss alternative means of resolving these complaints

by agreement. BellSouth respectfully requests that the Hearing Officer schedule a date certain for a mediation conference. BellSouth proposes that the mediation be held on Wednesday, November 14, 2001.

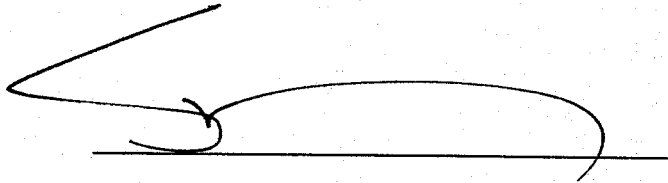
