APPLICATION FOR PERMISSION TO PRACTICE

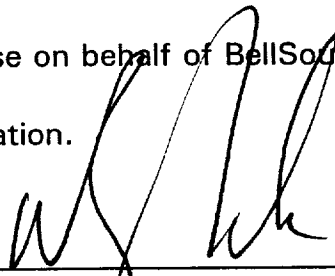

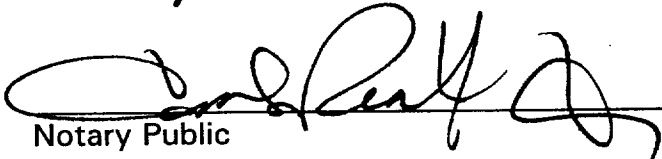
