QUITCLAIM DEED

FOR AND IN CONSIDERATION of the sum of One and no/100 (\$1.00) Dollar, cash in hand paid, the receipt of which is hereby acknowledged, I, DON R. CAMERON III (Grantor), have bargained and sold and by these presents does hereby quitclaim, transfer and convey unto TENNESSEE WASTEWATER SYSTEMS, INC. (formerly On-Site Systems, Inc.), a public utility company, (Grantee), its successors and assigns, the following described land situated in the 10th Civil District of Williamson County, Tennessee, and being more particularly described as follows:

Starting at an iron pin found on the southeasterly margin of Goose Creek Bypass, said point being the most southwesterly corner of Open Space "B" on the aforesaid plan of Addition to McLemore Farms, Section One, and the most northwesterly corner of the Don R.
