On March 19, Citizens Telecommunications Company of Tennessee and EZ Phone Inc. filed an Interconnection Agreement which was assigned the above referenced docket number. The purpose of this letter is to advise the TRA that the agreement filed was for the resell of services and not interconnection. Consequently, the term "resell" should be substituted for any reference to the term "interconnection" in the agreement. The agreement applies exclusively to the resell of services.

AMENDMENT ONE TO THE AGREEMENT FOR LOCAL INTERCONNECTION

This Amendment One to the Agreement for Local Interconnection (the "Agreement") between Citizens Telecommunications Company of Tennessee, LLC. ("Citizens") and EZ Phone, Inc. ("Carrier"), is made this 12th day of April, 2002. Citizens and Carrier are referred to herein collectively as the "Parties".

Citizens and Carrier entered into the Agreement on February 1, 2002.

Prior to gaining TRA approval of the February 1, 2002 agreement, Citizens' d/b/a name was changed.
