By this letter, Telecom North America, Inc., formerly known as 3U Telecom, Inc., ("Telna") respectfully requests cancellation of their resold interexchange authority in Tennessee. We have also enclosed 4 copies of this letter.

Telna has had no customers in Tennessee or elsewhere since January 31, 2016 and they now plan to close their business, effective December 31, 2016. Since Telna has no Tennessee customers, there will be no financial or consumer impact for granting this request. No outstanding fees are owed to any telecom funds and there is nothing pending. Since Telna is closing, Telna respectfully requests relief from upcoming annual filings and any other relief that the Tennessee Regulatory Authority will grant.

Responsibility for Loss or Damage

Claims not made within nine months after delivery of the package (sixty days for international shipments), or in the case of failure to make delivery, nine months after a reasonable time for delivery has elapsed (sixty days for international shipments), shall be deemed waived. The entry of a C.O.D. amount is not a declaration of value for carriage purposes. All checks or other negotiable instruments tendered in payment of C.O.D. will be accepted by UPS at shipper's risk.
