BELLSOUTH TELECOMMUNICATIONS, INC 'S FILING REGARDING AUDITOR AND AUDIT METHODOLOGY

BellSouth Telecommunications, Inc ("BellSouth") makes this Filing

Regarding Auditor and Audit Methodology and respectfully shows the Tennessee

Regulatory Authority ("Authority" or "TRA") as follows

On February 13, 2004, the Hearing Officer in this matter resolved issues raised in this docket with respect to BellSouth's right to conduct an audit of converted Enhanced Extended Link ("EEL") circuits, pursuant to the terms of interconnection agreements between BellSouth and two CLECs, and instructed BellSouth to provide information regarding the auditor it selected, as well as an overview of the methodology to be used by the auditor. Subsequent to that ruling, BellSouth settled its claims with one of the two CLECS. BellSouth has to date, however, been unable to resolve its dispute with Deltacom and has determined it should turn its focus toward proceeding with an audit.

BellSouth has selected and agreed to retain the firm of Grant Thornton, LLP to perform the audit of DeltaCom's converted EELs BellSouth is currently finalizing an engagement agreement, which it expects to be completed shortly BellSouth will defer to the professional judgment of its auditor with respect to all specific issues regarding the appropriate methodology to be used in this audit. As

a general matter, Grant Thornton will use the audit methodology outlined in the attached Exhibit A

As established in this matter, BellSouth has a contractual right to audit CLECs who convert special access to EELs and that right is governed by the parties' interconnection agreement BellSouth's choice of Grant Thornton and its intended methodology is consistent with all contractual provisions of the Moreover, as urged by the CLECs in this case, interconnection agreement BellSouth has chosen to engage an audit firm to perform an audit using AICPA Further, BellSouth has selected Grant Thornton rather than American standards Consultants Alliance ("ACA"), to which DeltaCom raised objections in this case BellSouth respectfully submits that there can be no legitimate suggestion that Grant Thornton is not "independent" as required by the interconnection agreement Decisions regarding the specific process of auditing should be left to the professional judgment of this reputable audit firm. In addition, in the event that BellSouth uses audit findings as the basis of any claim against DeltaCom, DeltaCom will have every opportunity to raise any issue it chooses with respect to the audit at that time

Exhibit A

Audit Methodology

Conduct audit of Enhanced Extended Links (EELs) from a CLEC, a list of the EEL circuits to be provided by BellSouth

Goal

To ascertain compliance with the terms of the interconnection agreements between BellSouth and CLEC as related to EELs

Scope

Data and records necessary to accomplish goal

Records Required

Records necessary based on options self-designated by CLEC, but may include the following

Option 1 EELs

- A LOA to CLEC or other similar document signed by the end user for each circuit (provided by CLEC),
- In absence of LOA Other written documentation for support that CLEC is the end user's only local service provider (provided by CLEC)
- Personal certification by senior management of compliance with this option
- Records of service establishment dates
- Records of service establishment and disconnect dates from other carriers

Option 2 EELs

- Total traffic and local traffic separately identified and measured as a percent of total end user customer local dial tone lines (provided by CLEC),
- For DS1 circuits and above Total traffic and local voice traffic separately identified individually on each of the activated channels on the loop portion of the loop-transport combination (provided by CLEC),
- Total traffic and local voice traffic separately identified on the entire loop facility (provided by CLEC),
- Total traffic and local voice traffic separately identified for each individual DS1 circuit when a loop-transport combination includes multiplexing (provided by CLEC)

Option 3 EELs

- The number of activated channels on a circuit that provide originating and terminating local dial tone service (provided by CLEC),
- The total traffic and the local voice traffic separately identified on each of these local dial tone channels (provided by CLEC),
- The total traffic and the local voice traffic separately identified for the entire loop facility (provided by CLEC),
- Total traffic and local voice traffic separately identified for each individual DS1 circuit when a loop-transport combination includes multiplexing (provided by CLEC)

AICPA-Compliance Assurance

Conduct an EELs audit that is in compliance with AICPA standards
