Latest update: though it looks like Bullseye currently has a payment credit with AT&T, it has not provided any feedback on the draft Transfer Agreement and OCA amendment, nor have they provided proof that they have changed the legal name on Bullseye's company codes (ACNA & OCNs) to reflect Lingo.

As such, AT&T TN is still billing Bullseye for Resale and Local Wholesale Complete services in Tennessee. Our negotiator has once again reached out to Bullseye to complete the process.

We received an email from Kathy Sager in late August that you would be the new regulatory contact for BellSouth/AT&T Tennessee beginning in early September. I look forward to working with you on regulatory matters.

Attached you will see a request for cancellation of the CCN of Bullseye Telecom, Inc., which has been operating as a CLEC in Tennessee since 2003. Before we cancel their CCN, we always verify with BellSouth/AT&T Tennessee that the company requesting cancellation is not being provided any resold lines or facilities-based services by BellSouth/AT&T Tennessee.

Can you please verify that BellSouth/AT&T Tennessee is not providing any resold or facilities-based services to Bullseye Telecom, Inc. at this time?

I'm hoping to put this cancellation request on our next Commission Conference Agenda which will be held in early November. If you can provide verification that no services are being provided to this company, it would be greatly appreciated.
