
The purpose of this letter is to notify the Tennessee Regulatory Authority ("TRA") that ITC^DeltaCom Communications, Inc. ("ITC^DeltaCom") intends to provide certain services under the trade name "Grapevine". Initially, ITC^DeltaCom intends to use such d/b/a in providing local and long distance services to Tennessee subscribers. ITC^DeltaCom will also continue to use and market products and services under the trade names "ITC^DeltaCom Communications Inc" and d/b/a "ITC^DeltaCom".

ITC^DeltaCom operates as a regional telecommunications company providing local and long distance services to consumers in the states of Alabama, Florida, Louisiana, Mississippi, Georgia, South Carolina and Tennessee and is authorized to provide telecommunications services by this Commission in Tennessee. ITC^DeltaCom also provides nationwide interstate and intrastate long distance services and international services.
