ORDER GRANTING APPLICATION TO APPEAR PRO HAC VICE

This matter came before the Hearing Officer on the *Application for Permission to Appear Pro Hac Vice* filed by Michael J. Henry, Martha M. Ross-Bain, Steven A. Augustino, and William Lee Magness, attorneys for AT&T Communications of the South Central States, LLC ("AT&T"). The Application was filed on March 26, 2004.

Mr. Henry's Application states that he is licensed and in good standing in the State of Georgia and that no disciplinary actions or investigations are pending against him.¹ Said Counsel agrees to subject himself to the jurisdiction of the Tennessee Regulatory Authority ("TRA" or "Authority") in any manner arising out of his conduct in such proceedings and agrees to be bound by the rules governing the conduct of attorneys appearing before the Authority.

Ms. Bain's Application states that she is licensed and in good standing in the States of Georgia and South Carolina, and that no disciplinary actions or investigations are pending against her.² Said Counsel agrees to subject herself to the jurisdiction of the TRA in any manner

arising out of her conduct in such proceedings and agrees to be bound by the rules governing the conduct of attorneys appearing before the Authority.

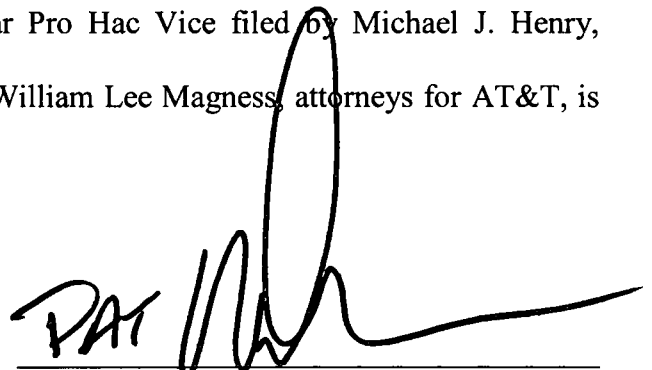
Mr. Augustino's Application states that he is licensed and in good standing in the District of Columbia and the State of Maryland and that no disciplinary actions or investigations are pending against him.³ Said Counsel agrees to subject himself to the jurisdiction of the TRA in any manner arising out of his conduct in such proceedings and agrees to be bound by the rules governing the conduct of attorneys appearing before the Authority.

Mr. Magness' Application states that he is licensed and in good standing in the State of Texas and that no disciplinary actions or investigations are pending against him.⁴ Said Counsel agrees to subject himself to the jurisdiction of the TRA in any manner arising out of his conduct in such proceedings and agrees to be bound by the rules governing the conduct of attorneys appearing before the Authority.
