This matter came before Director Pat Miller, Director Sara Kyle and Director Ron Jones of the Tennessee Regulatory Authority (the "Authority"), the voting panel assigned to this docket, at a regularly scheduled Authority Conference held on December 8, 2003, for consideration of the Application of Talton Communications to be an operator of Customer Owned Coin or Coinless Operated Telephone ("COCOT") service in the State of Tennessee.

Based upon careful consideration of the application and of the entire record of this matter, the voting panel finds and concludes that the applicant has met all the requirements of Tenn. Comp. R. & Regs. 1220-4-2-.43 through 1220-4-2-.45 to provide COCOT service in Tennessee.


IT IS THEREFORE ORDERED THAT:

1. Talton Communications is authorized to provide COCOT service within the State of Tennessee and is required to post the Company ID Number 128867 on the display card for each COCOT.


2. This Order shall remain in effect until further order of this Authority.




