ORDER REVOKING AUTHORITY TO PROVIDE COCOT SERVICES IN TENNESSEE FOR NON-PAYMENT OF FEES

This matter came before Director Pat Miller, Director Sara Kyle and Director Ron Jones of the Tennessee Regulatory Authority (the "Authority" or "TRA"), the voting panel assigned to this docket, at a regularly scheduled Authority Conference held on September 22, 2003, to revoke the authority of Tri-State Tel-Co (the "Company") to offer Customer Owned Coin or Coinless Operated Telephone ("COCOT") service in Tennessee due to non-payment of fees.

The Company originally filed its Application to provide COCOT service within the State of Tennessee on June 28, 1990. On June 29, 1990, the Tennessee Public Service Commission issued an order stating that the Company had met all the requirements to provide COCOT service in Tennessee.

Pursuant to Tenn. Code Ann. § 65-4-301, every owner or operator of a public pay telephone shall submit to the TRA an annual inspection and supervision fee for each service location on or before July 1 of each year. A notice advising the Company of its failure to comply with the requirements of Tenn. Code Ann. § 65-4-301 was mailed via certified mail on August 22, 2003. The Company failed to respond. As a result of this failure, this matter was

placed on the September 22, 2003 Authority Conference for the voting panel*assigned to this docket to consider revocation of the authority of the Company to provide COCOT service due to non-payment of fees.

Based upon careful consideration of the record of this matter, the panel voted unanimously to revoke the authority of Tri-State Tel-Co to provide COCOT service in Tennessee.

IT IS THEREFORE ORDERED THAT:

As a result of the non-payment of fees, the authority granted to Tri-State Tel-Co to provide COCOT service within the State of Tennessee is revoked, and this docket is closed.
