
This matter came before Chairman Deborah Taylor Tate, Director Sara Kyle and Director Ron Jones of the Tennessee Regulatory Authority (the "Authority" or "TRA"), the voting panel assigned to this docket, at a regularly scheduled Authority Conference held on January 5, 2004, for consideration of the Application of Gary's Market to be an operator of Customer Owned Coin or Coinless Operated Telephone ("COCOT") service in the State of Tennessee.

Based upon careful consideration of the application and of the entire record of this matter, the voting panel finds and concludes that the applicant has met all the requirements of Tenn. Comp. R. & Regs. 1220-4-2-.43 through 1220-4-2-.45 to provide COCOT service in Tennessee.


IT IS THEREFORE ORDERED THAT:
