Re: Request to Cancel the Certificate of CBTS Technology Solutions LLC

Dear Chairman Jones:

This letter surrenders CBTS Technology Solutions LLC's ("CBTS-TS") certificate of public convenience and necessity ("CCN") to provide resold and facilities-based local exchange and resold interexchange services granted in Docket No. 03-00647 under Company ID No. 128879.¹ If CBTS-TS has a current bond or letter of credit on file with the Commission, this letter also requests that the Commission authorize the cancellation of the bond or letter of credit and return it.

CBTS-TS no longer provides regulated telecommunications services in the state of Tennessee. The public will not be harmed by the surrender (and cancellation by the Commission) of the CCN held by CBTS-TS because the company no longer has customers receiving regulated telecommunications services. Further, the surrender is reasonable and necessary and not disruptive to the present or future public interest, convenience and necessity.
