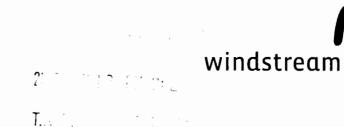

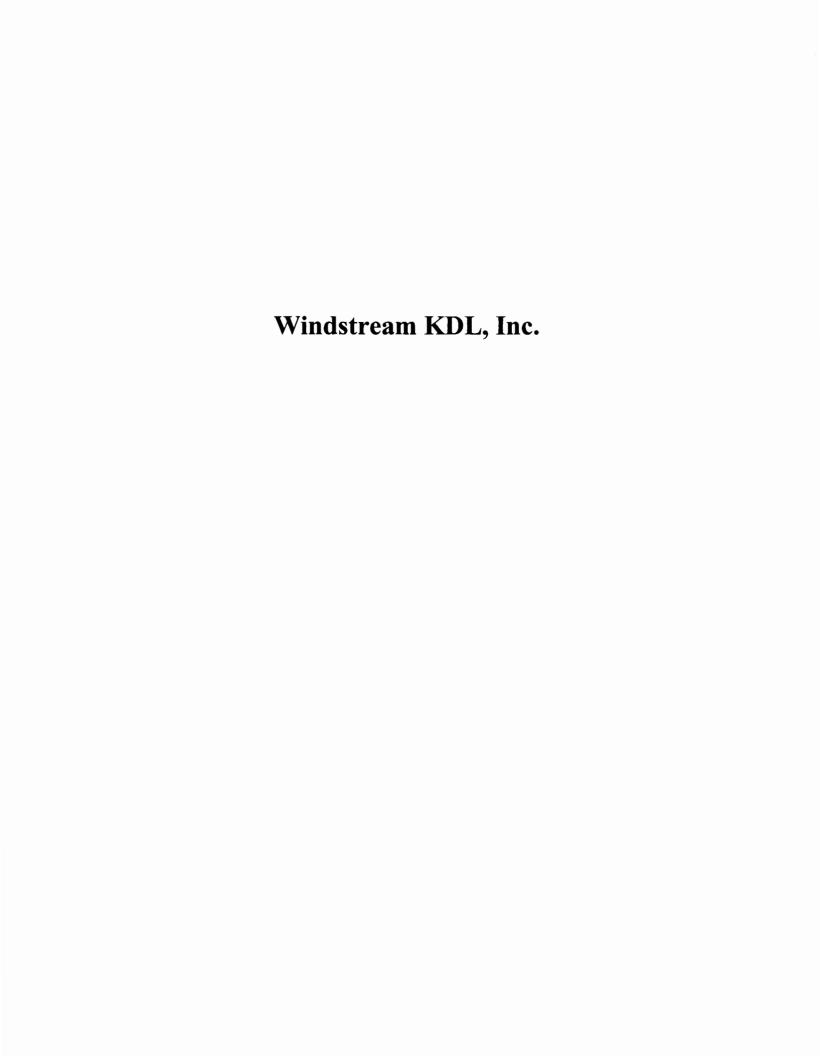

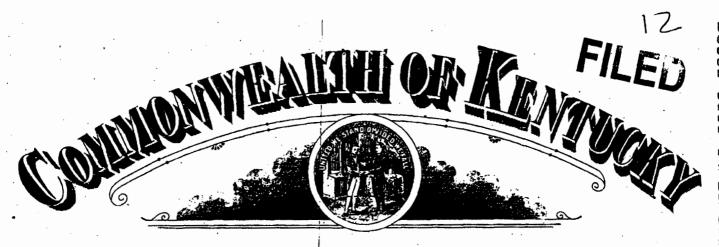

ARTICLE I: The name of the limited liability company is Windstream KDL, LLC.
