ORDER GRANTING MOTION FOR EXTENSION OF TIME

This matter is before the Pre-Arbitration Officer of the Tennessee Regulatory Authority ("Authority") upon the filing of a *Motion for Extension of Time to File Cost Study* ("*Motion*") by BellSouth Telecommunications, Inc. ("BellSouth") on April 28, 2006. At the regularly scheduled April 17, 2006 Authority Conference, the Arbitrators considered Item 65 (Issue 3-6). During their deliberations, the Arbitrators voted unanimously to require BellSouth to submit a Total Element Long Run Incremental Cost ("TELRIC") study for the Tandem Intermediary Charge ("TIC") in a newly-created docket within thirty (30) days.

In the *Motion*, BellSouth requests that it be given ninety (90) days from the April 17, 2006 Authority Conference, or until July 17, 2006, to file the cost study. In support of its request, BellSouth asserts that it has not been required to prepare such a cost study in any other

state and, consequently, will need more than thirty (30) days in order to prepare the study.²

NuVox Communications, Inc. and Xspedius Communications, LLC (for itself and on behalf of its operating subsidiaries) have not filed an objection to BellSouth's *Motion*.³

The Pre-Arbitration Officer finds that the *Motion* is reasonable and should be granted.

IT IS THEREFORE ORDERED THAT:

- 1. The Motion for Extension of Time to File Cost Study is granted.
- 2. BellSouth Telecommunications, Inc. shall file the TELRIC cost study for the Tandem Intermediary Charge in a newly-created docket no later than 2:00 p.m. on Monday, July 17, 2006.
