PETITION FOR APPROVAL OF THE AMENDMENT TO THE INTERCONNECTION AGREEMENT NEGOTIATED BETWEEN BELLSOUTH TELECOMMUNICATIONS, INC. AND BIRCH TELECOM OF THE SOUTH, INC. PURSUANT TO THE TELECOMMUNICATIONS ACT OF 1996

COME NOW, Birch Telecom of the South, Inc. ("Birch") and BellSouth Telecommunications, Inc., ("BellSouth"), and file this request for approval of the Amendment to the Interconnection Agreement dated July 14, 2000 (the "Amendments") negotiated between the two companies pursuant to Sections 251 and 252 of the Telecommunications Act of 1996, (the "Act") In support of their request, Birch and BellSouth state the following:

- 1. Birch and BellSouth have successfully negotiated an agreement for interconnection of their networks, the unbundling of specific network elements offered by BellSouth and the resale of BellSouth's telecommunications services to Birch. The Interconnection Agreement was approved by the Tennessee Regulatory Authority ("TRA") on March 20, 2001.
- 2. The parties have recently negotiated an Amendment to the Agreement. The Amendment incorporates terms and conditions for the Loop Qualification System. A copy of the Amendment is attached hereto and incorporated herein by reference.
- 3. Pursuant to Section 252(e) of the Telecommunications Act of 1996, Birch and BellSouth are submitting their Amendment to the TRA for its consideration and approval. The

Amendment provides that either or both of the parties is authorized to submit the Amendment to the TRA for approval

- 4. In accordance with Section 252(e) of the Act, the TRA is charged with approving or rejecting the negotiated Amendment between BellSouth and Birch within 90 days of its submission. The Act provides that the TRA may only reject such an agreement if it finds that the agreement or any portion of the agreement discriminates against a telecommunications carrier not a party to the agreement or the implementation of the agreement or any portion of the agreement is not consistent with the public interest, convenience and necessity.
- 5. Birch and BellSouth aver that the Amendment is consistent with the standards for approval.
- 6. Pursuant to Section 252(1) of the Act, BellSouth shall make the Agreement available upon the same terms and conditions contained therein.

Birch and BellSouth respectfully request that the TRA approve the Amendment negotiated between the parties.

Amendment to the Interconnection Agreement Between Birch Telecom of the South, Inc. and BellSouth Telecommunications, Inc. Dated July 14, 2000

Pursuant to this Amendment, (the "Amendment"), Birch Telecom of the South, Inc. d/b/a Birch Telecom and d/b/a Birch, collectively ("Birch"), on behalf of itself and its certificated operating affiliates identified in Part C hereof and BellSouth Telecommunications, Inc. ("BellSouth"), hereinafter referred to collectively as the "Parties," hereby agree to amend that certain Interconnection Agreement between the Parties dated July 14, 2000 ("Agreement") to be effective on the date of the last signature executing the Amendment

WHEREAS, BellSouth and Birch entered into the Agreement on July 14, 2000, and,

NOW THEREFORE, in consideration of the mutual provisions contained herein and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Parties hereby covenant and agree as follows

- 1 The Parties agree to add the following language to Attachment 2 of the Agreement
- 2 12 Birch may request access to the Loop Qualification System (LQS) LQS was originally designed as an internal tool utilized by BellSouth and Internet Service Providers (ISPs) selling BellSouth ADSL (Asymmetric Digital Subscriber Line) Service to determine if a telephone number(s) at a specific service address qualifies for BellSouth ADSL Service
- 2 12.1 In consideration of the terms and conditions enumerated below, BellSouth hereby agrees to provide the customer access to LQS and a bulk list of ADSL qualified customers from LQS
- 2 12 1 1 BellSouth makes no claim as to the accuracy or completeness of either LQS or the bulk list
- 2 12.1 2 Birch is responsible for acting within the local, state, and federal law governing the use of the bulk list for the purpose of, but not limited to, marketing of its own DSL service through direct mail or telemarketing Furthermore, Birch hereby agrees to refrain from abusive telemarketing practices

- 2 12 1 3 Birch agrees to use the LQS information and the bulk list and/or any information directly derived from the bulk list for the sole purpose of qualifying and selling its own DSL services (whether by itself or in a package of other offerings)
- 2 12 1 4 Birch will not use the bulk list for the purpose of conducting research, marketing, qualifying, or selling products and/or services other than its own DSL services
- 2.12 1 5 Birch will not provide the bulk list, any portion or portions of the bulk list, copies of the bulk list, or any information derived directly from the bulk list to others without the prior written consent of BellSouth
- Birch acknowledges and agrees to BellSouth's right to revoke and terminate the use of the bulk list by Birch—BellSouth may exercise this right of revocation and/or termination at any time, for any purpose, by oral or written notice to Birch—In such event, Birch agrees to immediately destroy or return all copies and/or components of the bulk list—For purposes of this paragraph, the term "immediately" shall be defined as a period of time not to exceed forty-eight (48) hours
 - 2 All of the other provisions of the Agreement, dated July 14, 2000, shall remain in full force and effect
 - 3 Either or both of the Parties is authorized to submit this Amendment to the respective state regulatory authorities for approval subject to Section 252(e) of the Federal Telecommunications Act of 1996
