Comments should include specific information about the impact of this proposed discontinuance upon you or your company, including any inability to acquire reasonable substitute service.

PETITION TO DISCONTINUE SERVICE AND WAIVER FOR NOTICE

Network PTS, Inc. ("Petitioner") hereby requests, pursuant to Section 214 of the Communications Act of 1934, as amended, 47 U.S.C. Section 214, and Section 63.71 of the Commission's Rules, 47 C.F.R. Section 63.71, to discontinue domestic services as a reseller of telecommunications services.



- 2. Petitioner was authorized to provide telecommunications services in the form of operator services from pay telephones in all states except Alaska, Alabama, Colorado, Connecticut, Delaware, Maryland, Rhode Island, South Carolina, South Dakota, Vermont and West Virginia. Petitioner has provided notice of discontinuance of service and cancellation of authority in the form of an Application, Petition or Letter to all of the states in which the company was certificated.
- 3. Petitioner is a non-dominant with respect to the service being discontinued. The company provides operator services to pay telephone aggregator locations. The public convenience and necessity will not be adversely affected, because customer will be able to receive the same service or a reasonable substitute from a wide array of other carriers throughout the country.
- 4. Customer notice is not applicable since the Petitioner does not have any customers. The company has faced competition which has caused its customer base attrition. Moreover, the Company does not have any outstanding obligations in the form of advance payments, deposits or prepayments.
- 5. Notice has been sent to the State Regulatory agencies, Governors' offices and the Department of Defense, as required under Section 63.71, concurrent with this filing. A service list is provided in Exhibit A.
- 6. Through separate correspondence, Network PTS requests cancellation of its international 214 license: ITC-214-20030703-00330.

Conclusion

Pursuant to Section 214 of the Communications Act of 1934, as amended, 47 U. S. C. Section 214, and Section 63.71 of the commission's Rules, 47 C. R. R. Section 63.71, Network PTS, Inc. understands that this application will be automatically granted on the 31st day after the Public Notice is released, with no Commission notification to the Company, unless the Commission has notified the company that the grant will not be automatically effective.
