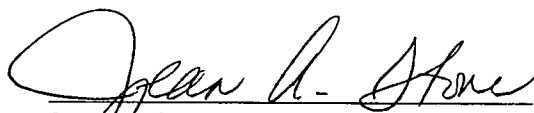

Code Ann. § 4-5-101 *et seq.* The voting panel assigned to this Docket will conduct the Hearing and deliberate the merits of the above-captioned proceeding.

All parties are entitled to be represented by counsel. 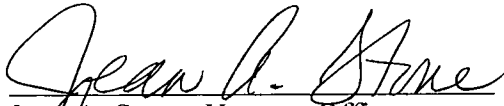
