Dear Chairman Jones:

MCI Communications Services, Inc. ("MCI") files this letter in response to the instructions to the parties given by the Tennessee Regulatory Authority (the "Authority") at the Authority's agenda conference on February 21, 2006. vCustomer filed a letter with the Authority on March 1, 2006 advising the Authority that vCustomer still had not filed a claim with MCI regarding the termination of the Asset Purchase Agreement (the "APA") between MCI and vCustomer, and acknowledging that the Authority had no jurisdiction to address that claim. As indicated in the letter filed by MCI on November 2, 2005, no action by the TRA is required on this matter. Amendment 1 to Contract NC-02-00629-00 between the State of Tennessee, the Authority and MCI (the "Contract"), which was executed to effectuate the assignment of the Contract to vCustomer, provides that the amendment would become effective upon the closing of the transaction between MCI and vCustomer pursuant to the APA. MCI's request to vacate the Authority's order was solely a matter of housekeeping and would not affect the substantive rights of either MCI or vCustomer. The Authority may either vacate the order or simply leave it in place, in which case MCI will inform the Authority in the event the transaction closes.


