## ORDER APPROVING PETITION TO AMEND CERTIFICATE OF PUBLIC CONVENIENCE AND NECESSITY

This matter came before Chairman Ron Jones, Director Deborah Taylor Tate and Director Pat Miller of the Tennessee Regulatory Authority (the "Authority" or "TRA"), the voting panel assigned to this docket, at a Hearing held on September 7, 2005 to consider the *Petition of On-Site Systems, Inc. to Amend its Certificate of Convenience and Necessity* ("Petition of On-Site Systems") filed by Tennessee Wastewater Systems, Inc. <sup>1</sup> ("TWS" or the "Company") requesting an amendment to the Company's certificate of public convenience and necessity ("CCN").

On April 6, 1994, TWS received a CCN in Docket No. 93-09040 from the Tennessee Public Service Commission to provide wastewater service to the Oakwood Subdivision in Maury County Since that time, through various other dockets, the Company has been granted approval to expand its service territory to include other areas in Tennessee.

On August 6, 1997, TWS filed the Petition of On-Site Systems, Inc. to Amend its Certificate of Convenience and Necessity ("Petition to Amend") with the Authority requesting that its CCN be amended to include part of the Milcroston Utility District.<sup>2</sup> The Petition to Amend was unanimously

approved on September 23, 1997, and an order was issued on March 31, 1998 evidencing such approval

On October 5, 2004, King's Chapel Capacity, LLC ("King's Chapel") filed a *Petition*<sup>3</sup> requesting a CCN to provide wastewater service to the Ashby Communities Development in Williamson County, Tennessee. The Authority assigned Docket No. 04-00335 to the Petition. The Ashby Communities Development is within the portion<sup>4</sup> of the Milcrofton Utility District that is included in the CCN previously granted to TWS in Docket No. 97-01393 to provide wastewater service <sup>5</sup>

On October 11, 2004, TWS filed the *Petition to Intervene of Tennessee Wastewater Systems*, *Inc* <sup>6</sup> ("*Petition to Intervene*") requesting that TWS be allowed to intervene in Docket No 04-00335. In its *Petition to Intervene*, TWS represented that since TWS already possesses a CCN to serve the area, the conflicting request for a CCN filed by King's Chapel must be denied. On November 22, 2004, the panel voted unanimously to grant TWS's *Petition to Intervene*, to appoint a Hearing Officer to hear preliminary matters prior to the Hearing and to set a procedural schedule to completion.<sup>7</sup>

On July 25, 2005, TWS filed a *Notice of Settlement and Withdrawal of Objections*<sup>8</sup> informing the Authority that the parties had reached a settlement and withdrawing its objection and opposition to the *Petition* filed by King's Chapel, which requested a CCN to provide service to the Ashby Communities Development.

Pursuant to the settlement agreement, TWS filed the *Petition of On-Site Systems* on July 25, 2005 requesting an amendment to the CCN it received from the Authority in Docket No. 97-01393 in order to eliminate duplication of the service area requested by King's Chapel in Docket No. 04-00335 

In a Data Response, TWS clarified that it seeks to be withdrawn from the subdivisions that occupy parcels 22, 40, 43.01 and 43 as shown on Williamson County Map 109. 

TWS also stated that it does not serve any customers in the areas that it seeks to withdraw from its CCN.

During the Hearing held on September 7, 2005, the panel considered the *Petition of On-Site*Systems The panel found that this is a voluntary withdrawal of a portion of TWS's CCN and that TWS is not providing service to customers in the subject area and voted unanimously to grant the 
Petition of On-Site Systems and amend the Company's CCN by withdrawing the subdivisions shown on Williamson County Map 109 that are made up of the following parcels: 22, 40, 43 01 and 43.
