**ORDER GRANTING REQUEST TO CANCEL AUTHORITY TO PROVIDE
TELECOMMUNICATION SERVICES**

This matter came before Chairman David F. Jones, Vice Chairman Clay R. Good, Commissioner Herbert H. Hilliard, Commissioner Robin L. Morrison, and Commissioner John A. Hie of the Tennessee Public Utility Commission (the “Commission” or “TPUC”), the voting panel assigned to this docket, during a regularly scheduled Commission Conference on August 17, 2026. The panel convened to consider AccessLine Communications Corporation’s (“ACC” or the “Company”) request, filed on April 29, 2026, to cancel its authorization as an interexchange reseller of telecommunications services, including any applicable tariffs granted in Docket 05-00232 under Company ID 128967 in Tennessee.¹

On January 4, 2026, the Commission granted ACC a Certificate of Public Convenience and Necessity to provide resold interexchange telecommunications services.² In its cancellation request, ACC stated that it no longer offers or provides intrastate telecommunications services in

Tennessee and affirmed that relinquishing its CCN would have no adverse effect on the public. ACC is in good standing with the Commission, and its inspection fees are current. After careful consideration of the entire record in this matter, the panel voted unanimously to grant the Company's cancellation request.

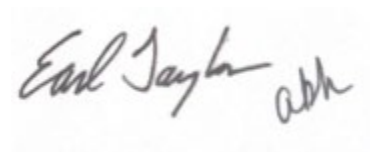
