On November 7, 2006, you submitted customer and usage volumes on behalf of Atmos Energy Corporation. Please provide the following additional information to assist us in our analysis.

- For rate class 230 LRG COM/IND GS, volumes were separated between commercial and industrial categories for the months contained in the November 7, 2006 filing. All usage was categorized as industrial in previous filings. Please provide volumes for October 2005 – April 2006 for rate class 230 LRG COM/IND GS separated into commercial and industrial categories.
- 2. Similarly, rate class 260 TRANSP (250 OPT GS) was separated between the transportation and commercial categories in the November 7, 2006 filing. Please explain and provide a similar classification for October 2005 April 2006 volumes.
- 3. The November 7, 2006 filing does not appear to contain any volumes for "handbills" included in earlier filings. Please provide this information for all applicable rate classes.
- 4. The November 7, 2006 filing contained a commercial rate class 230 LRG TRAG which was not included in previous filings. Please explain and provide volumes for this rate class for the months October 2005 April 2006.
- 5. The November 7, 2006 filing did not contained a commercial rate class 240 DEMAND/COM GS which was a part of previous filings. Please explain and provide volumes for this rate class for the months May 2006 September 2006.

It is requested that this information be provided no later than 2:00 p.m. on November 22, 2006, and that you reference Docket No. 05-00258 on the response. In accordance with TRA rules submit either (1) thirteen written copies of your response or (2) four written copies and an
