The stipulation approved by the Authority in docket 05-00281at its November 7, 2005 conference provides that beginning on November 15, 2005 and continuing through April 15, 2006 Chattanooga Gas Company report to the Authority on a monthly basis, (1) the number of residential customers whose service was terminated for non-payment during the preceding calendar month; (2) the number of residential customers whose service was terminated for non-payment during the same calendar month of the prior year; (3) the number of residential customers participating in the company's equal payment plan during the preceding calendar month; and (4) the number of residential customers participating in the company's equal payment plan during the same month for the preceding year.
