

PETITION FOR APPROVAL OF THE
AMENDMENT TO THE INTERCONNECTION AGREEMENT
NEGOTIATED BETWEEN BELL SOUTH TELECOMMUNICATIONS, INC.
AND ELECTRIC POWER BOARD OF CHATTANOOGA
PURSUANT TO THE TELECOMMUNICATIONS ACT OF 1996

COME NOW, Electric Power Board of Chattanooga ("EPB Telecommunications") and BellSouth Telecommunications, Inc., ("BellSouth"), and file this request for approval of the Amendment to the Interconnection Agreement dated July 17, 2003 (the "Amendment") negotiated between the two companies pursuant to Sections 251 and 252 of the Telecommunications Act of 1996, (the "Act"). In support of their request, EPB Telecommunications and BellSouth state the following

1. EPB Telecommunications and BellSouth have successfully negotiated an agreement for interconnection of their networks, the unbundling of specific network elements offered by BellSouth and the resale of BellSouth's telecommunications services to EPB Telecommunications. The Interconnection Agreement was approved by the Tennessee Regulatory Authority ("TRA") on August 18, 2003.

2. The parties have recently negotiated an Amendment to the Agreement. The Amendment incorporates CNAM language in Attachment 2 to the Agreement. A copy of the Amendment is attached hereto and incorporated herein by reference.

3. Pursuant to Section 252(e) of the Telecommunications Act of 1996, EPB Telecommunications and BellSouth are submitting their Amendment to the TRA for its consideration and approval. The Amendment provides that either or both of the parties is authorized to submit the Amendment to the TRA for approval.

4 In accordance with Section 252(e) of the Act, the TRA is charged with approving or rejecting the negotiated Amendment between BellSouth and EPB Telecommunications within 90 days of its submission. The Act provides that the TRA may only reject such an agreement if it finds that the agreement or any portion of the agreement discriminates against a telecommunications carrier not a party to the agreement or the implementation of the agreement or any portion of the agreement is not consistent with the public interest, convenience and necessity.

5 EPB Telecommunications and BellSouth aver that the Amendment is consistent with the standards for approval

EPB Telecommunications and BellSouth respectfully request that the TRA approve the Amendment negotiated between the parties.



**Amendment to the Agreement
Between
Electric Power Board of Chattanooga
and
BellSouth Telecommunications, Inc.
Dated July 17, 2003**

Pursuant to this Amendment, (the "Amendment"), Electric Power Board of Chattanooga ("EPB Telecommunications"), and BellSouth Telecommunications, Inc. ("BellSouth"), hereinafter referred to collectively as the "Parties," hereby agree to amend that certain Interconnection Agreement between the Parties dated July 17, 2003 ("Agreement") to be effective thirty (30) calendar days after the date of the last signature executing the Amendment ("Effective Date").

WHEREAS, BellSouth and EPB Telecommunications entered into the Agreement on July 17, 2003, and;

NOW THEREFORE, in consideration of the mutual provisions contained herein and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Parties hereby covenant and agree as follows:

1. The Parties agree to add new Section 12.10 to Attachment 2, as follows:

12.10 BellSouth shall bill for CNAM queries the rate set forth in Exhibit B. In the event BellSouth is unable to bill per query, BellSouth shall bill EPB Telecommunications at the applicable rates set forth in Exhibit B based on a surrogate of two hundred and fifty-six (256) database queries per month per EPB Telecommunications's End Users with the Caller ID feature.
2. All of the other provisions of the Agreement, dated July 17, 2003, shall remain in full force and effect.
3. Either or both of the Parties are authorized to submit this Amendment to the respective state regulatory authorities for approval subject to Section 252(e) of the Federal Telecommunications Act of 1996.
