Scott County Telephone Cooperative serves approximately 65 customers in Hancock County, Tennessee. These customers can dial 211, which are forwarded to the Virginia Department of Social Services Information and Referral in Richmond, Virginia. This is the same location that all of the other Scott County Telephone Cooperative customers are directed to when they dial 211. This number is advertised as "access to community information and referral services" (FCC Docket No. 92-105).

211 dialed from Hancock County customers can be directed to a toll free number to terminate to a location in Tennessee if so directed. However, SCTC feels that this number should be in the best interest for the residents of Hancock County. For a call to terminate to a regional interest, such as the United Way of Metropolitan Nashville, is probably not in the best interest of SCTC's customers.
