In order to fully analyze the above-referenced petition, the Tennessee Regulatory Authority (TRA) requires additional information. Please provide the information requested below by March 16, 2006, and refer to this correspondence as Data Request No. 1 in the response.

1. Provide a citation to a statute, rule, or order which warrants the application's approval.
2. Has CTC Communications Group, Inc. ("CTC"), CTC Communications Corp. ("CTC Communications"), and Choice One ("Choice One") (collectively, the "Applicants") filed similar applications in other states and what is the status of any such application?
3. Have Applicants applied for approval for financing from any Federal agency? Have they notified any Federal Agency? If so, what is the status of any such application, petition, or notification?
4. How many customers do CTC Communications currently have in Tennessee?
5. Will all CTC Communications customers in Tennessee merge with and into Choice One (as part of the CTC-Choice One merger transaction)?

6. Explain what are current and future plans for existing CTC residential and business customers in Tennessee.
7. Confirm that CTC Communications will continue to operate and/or provide service under its current name and CCN issued by the Authority, and its business licenses as filed with the Tennessee Secretary of State's Office.
8. Per the Application filed with the Authority on February 23, 2006, file the Agreement and Plan of Merger ("Merger Agreement") the Applicants entered into on February 9, 2006, by and between CTC Verify all current CCNs issued with the Authority, and provide copies of all current business licenses of CTC filed with the Tennessee Secretary of State's Office.
