of its Telecommunications Authorization and Tariff

Dear Ms. Dillon:

Nextlink Wireless, LLC (Nextlink or Company) respectfully requests that the Regulatory Authority (Authority) cancel the Company's certificate to provide local exchange and interexchange services in Tennessee and the associated tariff.

The Authority granted Nextlink a certificate to provide facilities-based and resold local exchange and interexchange services in Tennessee on October 6, 2006 in Docket No. 06-00066.¹ The Company subsequently determined that its strategic business plans do not include the provision of facilities-based and resold local exchange and interexchange services. Nextlink has no customers in Tennessee for facilities-based and resold local exchange and interexchange services. Accordingly, there are no customers to be notified regarding this request, and cancellation of Nextlink's certificate and associated tariff will have no adverse consequences for consumers in Tennessee.

¹ The Company's application was filed under its original name of LMDS Holdings, Inc. In the course of the proceeding, the Company changed its name to Nextlink Wireless, Inc. and the certificate was issued in that name. On January 11, 2012, the Authority approved the Company's filing in connection with Nextlink's conversion into a Delaware limited liability company and resulting name change to Nextlink Wireless, LLC.






