CLEC applicants are required, by statute, to demonstrate their managerial, financial and technical abilities to provide the services for which they seek authority. To assist the Authority in its review of YMax Communications Corp.'s application for a Certificate of Convenience and Necessity to provide competing facilities-based local services in Tennessee, you are requested to provide the following information:


1. The Financial Statements provided as exhibit F-1 of the application indicate \$1,000 in Checking/Savings and \$5,000,000 as a Line of Credit Available. Who is providing this Line of Credit? Supply a statement from the lender/investor/individual as to their intention to guarantee this amount to YMax Communications Corp.
2. A sample bill.
3. Tenn. Code Ann. § 65-4-125 states that by September 1, 2000, all telecommunications service providers subject to control and jurisdiction of the authority, except those owners or operators of public telephone service who pay annual inspection and supervision fees pursuant to Tenn. Code Ann. § 65-4-301 (b), or any telecommunications service provider that owns and operates equipment facilities in Tennessee with a value of more than five million (\$5,000,000), shall file with the authority a corporate surety bond or irrevocable letter of credit in the amount twenty thousand dollars (\$20,000) to secure the payment of any monetary sanction imposed in any enforcement proceeding, brought under this title or the Consumer Telemarketing Protection Act of 1990, by or on behalf of the authority. Will the value of your company's equipment or facilities in Tennessee be in excess of \$5,000,000? If not, please provide a corporate surety bond or irrevocable letter of credit in the amount of twenty thousand dollars (\$20,000).

4. Pre-filed testimony in regard to the managerial, technical and financial capabilities of YMax Communications Corp.

5. Exhibit H of the application, titled Notice of Filing, lists the eighteen ILECs in Tennessee who are required to be notified of this filing. However, there was no dated or signed certificate of service included with this exhibit. Please provide a signed and dated certificate of service for the Notice of Filing.

Please provide the above information by April 10, 2006. In accordance with TRA Rules, please submit either (1) thirteen written copies of your response or (2) four written copies and an electronic version.
