I, Daniel Borislow, do hereby testify as follows in support of the application of YMax Communications Corp. ("YMax") for a Certificate of Convenience and Necessity as a competing telecommunications services provider to provide facilities-based long distance and local exchange telecommunications services throughout the State of Tennessee.

- Q. Please state your name and business address.
- A. My name is Daniel Borislow. My business address is 223 Sunset Avenue, Suite 223, Palm Beach, Florida 33480

- Q. By whom are you employed and in what capacity?
 - A. I am employed by YMax Communications Corp., and hold the position of CEO and President.
 - Q. Please give a brief description of your background and experience.
 - From May 1989 through January 1999, I served as CEO and a Director of Tel-Save Holdings now Talk America. Tel-Save was a very profitable corporation. As the largest reseller and customer of AT&T, Tel-Save offered wholesale long distance to other resellers through marketing and partnership agreements. I took the company public in 1995 and built our own long distance network by strategically deploying five (5) Lucent class 5E switches across the United States. In 1997 I negotiated exclusive marketing rights with America Online and was the first company to offer services online with online billing, provisioning and customer service and a price point substantially lower then the rest of the market. Prior to my founding Tel-Save Incorporated, I built the cable systems in the city of Philadelphia

Q. What is the purpose of your testimony?

The purpose of my testimony is to present evidence describing the technical, managerial and financial fitness of YMax Communications Corp. to provide Facilities-Based Local Exchange Service in Tennessee. This testimony will also describe the services proposed by YMax Communications Corp. and the proposed tariff structure. Finally, the purpose of my testimony is to show that the public interest will be served by approval of the application of YMax Communications Corp. for a certificate of public convenience and necessity to provide facilities-based service.

Q.	Has I wax registered to do business in Tennessee:
A.	Yes. The Applicant is a Delaware Corporation, authorized by the Tennessee Secretary of State to

	YMax Communications Corp. is a privately held corporation. YMax Communications Corp. is a
	Delaware corporation formed on May 24, 2005. Its parent company, YMax Corporation is also a
	Delaware corporation, formed on January 25, 2005.
Q.	Has YMax previously obtained authority in Tennessee?

Q.	Please describe the services YMax proposes to offer.
A.	YMax initially proposes to provide local service using unbundled network combinations available
	from BellSouth and via resold services. YMax may eventually provide local services via its own
	switching facilities.
Q.	How will YMax bill for its services?
A.	YMax will bill customers directly.
Q.	How are trouble reports, billing errors and complaints handled?
A.	YMax Communications Corp. provides its own Customer Service to Customers whom the
	Company bills directly. The Customer Service Department is open twenty-four (24) hours a day,
	seven (7) days a week. YMax's toll free telephone number for customer inquiries, complaints and

Q. Describe YMax's financial ability to operate as a local service provider.

A. YMax Communications Corp. is a start-up company and has not yet initiated operations in any state. I intend to provide the financial resources to support the Company's operations during its start-up period of operations. Company's Financial Statement is included in the Company's application and additional information regarding my financial capability is available upon request.

Q. Does YMax have the managerial and technical qualifications to provide local service in Tennessee?

10 A. Yes. YMax has a very strong and experienced management team. Biographies of key executives and technical personnel have been included with the Company's application.

Where in Tennessee does YMax intend to offer its services?

A. Local exchange service will be offered within the present operating areas of BellSouth within Tennessee.

How will Tennessee consumers benefit from YMax's services?

A. Certification of YMax Communications Corp. will serve the public interest and offer several benefits to local telecommunication customers in Tennessee. Experience with competition in other telecommunications markets demonstrates the benefits that competition can bring to consumers. YMax's proposed services will provide multiple public benefits by increasing the competitive choices available to users in Tennessee. Enhanced competition in telecommunications services likely will further stimulate economic development in Tennessee. In addition, increased competition will create incentives for all carriers to offer lower prices, more innovative services, and more responsive customer service.

Q. Why is YMax seeking facilities-based authority in Tennessee? Will YMax use any public rights-of-way?

A.

YMax plans to purchase unbundled network elements (UNE) and interconnection arrangements from BellSouth and therefore requires facilities-based authority. Since YMax has no immediate plans to deploy cable or fiber, it does not foresee using public rights-of-way in the next two quarters. However, YMax does request the Commission's consent to use public rights-of-way pursuant to applicable laws for possible future installations.
