- 2. Have the applicants filed a similar application with the FCC or other federal agency? If so, list any action taken and the associated file(s) or document number(s). If a schedule to complete the review of your application has been established by any federal agency, provide such with your response.
- 3. As required by FCC Rules in CC Docket No. 00-257, provide a copy of the self-certification letter filed with the FCC regarding transfer transactions.
- 4. Provide the number of customers that Electric Lightwave, LLC ("ELI") currently has in Tennessee.
- 5. Will all ELI customers in Tennessee be transferred to Integra Telecom Holdings, Inc. ("Integra")?

- 6. Consistent with TRA Rule 1220-4-2-.56(2) (d), provide a current customer notice or letter informing customers of the change in ownership and/or operating authority.
- 7. Provide copies of all current CCNs of Integra issued by the Authority, and provide copies of all current business licenses of Integra filed with the Tennessee Secretary of State's Office.
- 8. Confirm that applicants will continue to operate under their present CCNs issued by the Authority and business licenses as filed with the Tennessee Secretary of State's Office.
- 9. File the Membership Interest Purchase Agreement ("Agreement") the Applicants entered into on February 6, 2006, per the Joint Application filed with the Authority on March 17, 2006.
- 10. Provide a signed statement and/or verification from ELI, its attorney, or legal party representatives verifying that the information contained in the Joint Application is true and correct to their best knowledge, information, and belief.
