- 2. I am writing to the Tennessee Regulatory Authority to get approval to buy out my partner, Randy C. Allen. We are co-owners of Antioch Water Company located in the Springville area of Henry County Tennessee. Mr. Allen has had serious medical problems the last few years. He had lung cancer, which later progressed to brain cancer. He has had surgery, removing half of his lung and also a tumor removal from his brain. Since these surgeries he has suffered multiple strokes. He is currently unable to participate in the operation of the business and wishes to sell his half to me. I am presently taking care of all the operations of the company.
- 3. I, Ted R. Fields, pursuant to T.C.A. @ 65-4-113 am requesting transfer of ownership from my partner, Randy C. Allen. Mr. Allen and I have been co-owners of Antioch Water Company since April 1, 1993. I am assuming all debt and liability of the company when the ownership is transferred. The utility will be run in the same manner that it has in the past. The public will not be affected by this transfer. I hope to continue to improve the service of the utilities to its customers.
- 4. My partner, Randy C. Allen, held the certificate of convenience and necessity. We are not able to locate this certificate in our files. I contacted Mr. Carlos Black as well as Ms. Sharla Dillon about getting a copy of this certificate. The certificate was granted June 27, 1996 from the Public Service Commission. Mr. Black said I need to submit the application and he would attach it to this letter. This pursuant to T.C.A. 95-3172. The company ID number is 115450. We had a rate increase, docket number 95-03172 on August 29, 1995.
- 5. The only affected area will be that of a rate increase that was approved. The docket number for this hearing was a 99-00584. This is the only case that Antioch Water Company has brought before the Tennessee Regulatory Authority. The transfer off ownership will not affect this case in any manner.

- 6. The only state affected by the utility is Tennessee, located in Henry County.
- 7. There will be no change in regulated services or tariff conditions by this transaction.
- 8. The public interest will not be affected at all by this transaction. The utility will continue to operate as it has in the past. I will strive to improve the services of the utility to better serve the customers.
- 9. I, Ted R Fields and Randy C. Allen, verify that all information in this application is correct and accurate to the best of our abilities.
- 10. Antioch Water Company will continue to operate in the same manner as it has in the past. I will strive to improve the utility and its service to the customers as we always have.
