

Petitioners, AT&T Communications of the South Central States, LLC and TCG MidSouth, Inc., hereby respectfully petition the Tennessee Regulatory Authority ("TRA") to intervene in the above-captioned proceeding pursuant to T.C.A. § 4-5-310(a).

AT&T Communications of the South Central States, LLC is a competitive local exchange carrier authorized to provide intraLATA and interLATA telecommunications services. TCG MidSouth, Inc. is authorized to provide facilities-based and resold local exchange and interexchange telecommunications services. Both Petitioners hold certificate(s) of public convenience and necessity issued by the TRA.


As the stated purpose of this proceeding is to establish a rate for switching provided pursuant to requirements other than 47 U.S.C § 251, such rate(s) set herein may affect the business and rates charged to or by Petitioners and may also indirectly affect their customers. Accordingly, this proceeding will address, among other things, certain terms and conditions under which Petitioners may operate in Tennessee. The legal rights, duties, privileges, immunities or other legal interests of Petitioners may be determined in this proceeding.

Petitioners' interests will not be adequately represented unless allowed to intervene. Granting this Petition will not impair the interests of justice or the orderly and prompt conduct of these proceedings.

1. An Order be entered allowing Petitioners to intervene and participate in this proceeding, as their interests may appear, and to receive copies of all notices, pleadings, orders and other documents that are filed herein; and
2. Petitioners have such other, further and general relief to which they may be entitled.


