


Time Warner Telecom of the Mid-South, LP ("TWTC") petitions the Tennessee Regulatory Authority ("TRA") to intervene in the above captioned proceeding pursuant to T.C.A. §4-5-310(a). In support of its Petition, TWTC respectfully states as follows:

1. On March 31, 2005, AT&T Inc., and Bellsouth Corporation together with its certified subsidiaries filed the above-referenced joint application with the TRA.
2. TWTC is certified by the TRA as a provider of telecommunications services throughout the State of Tennessee.
3. As it is a competing certified telecommunication service provider, TWTC's legal rights, duties, privileges, immunities, may be affected or determined by the outcome of this proceeding, and Petitioner's interest or other legal interests or responsibilities will not be adequately represented unless allowed to intervene. Granting this petition will not impair the orderly and prompt conduct of these proceedings.

4. **WHEREFORE, PREMISES CONSIDERED**, TWTC, prays that it be granted leave to intervene and participate in this proceeding with all attendant rights and responsibilities, including but not limited to the right to participate in any and all pre-hearing conferences, to produce and cross examine witnesses, to seek data requests and other discovery, and to file motions, briefs, testimony, and/or comments in order to assist the commission's deliberations and otherwise protect the interests of TWTC and the public interest. Additionally, Petitioner requests receive copies of any notices, orders or any other documents filed herein, and have such other, further and general relief as the justice of their cause entitle them to receive.


