On behalf of my client, NuVox Communications, Inc., I am submitting the following  
responses to the data requests of April 18, 2006:

(1) Has NuVox Communications, Inc. ("NuVox Communications") filed similar  
applications in other states and what is the status of any such application?

RESPONSE:

Yes. NuVox Communications has made similar filings in other states. NuVox  
Communications has filed notifications of the financings in the following states: Indiana,  
Kentucky, Louisiana, and North Carolina. NuVox Communications has filed an application that  
has been approved in Georgia. NuVox Communications has filed an application that is pending  
in Missouri.

(2) Has NuVox Communications applied for approval for financing from any federal  
agency? Has it notified any federal agency? If so, what is the status of any such application or  
notification?

RESPONSE:

No. NuVox Communications has not applied for approval for financing from or notified  
any Federal agency. This type of multi-state financing transaction does not require review or  
approval from any Federal agency, or for the parties involved to provide notice to any federal

RESPONSE:

(4) Will any Tennessee assets be pledged as collateral for any debt issued? If so, name the particular asset(s), and the percentage of each particular asset(s) pledge.

RESPONSE:

Yes. It is anticipated that NuVox Communications will pledge Tennessee assets as collateral for any debt issued. All of the assets in Tennessee are pledged, including network equipment, leasehold improvements, network electronics, cross-connects, data equipment, collocation equipment, customer premises electronics, CPE integrated access devises, tools, operations support system software, computer hardware, office furniture and equipment and vehicles.

(5) Provide the most recently independently audits balance sheet and operating statement of revenues for NuVox Communications.

RESPONSE:

NuVox Communications is a subsidiary of NuVox, Inc., its ultimate parent company and privately held company. A copy of NuVox, Inc.'s most recently independently audited balance sheets and operating statement of revenues is appended hereto as Attachment B which is filed under seal due to such information being confidential and proprietary. These financials cover NuVox, Inc.'s subsidiaries, including NuVox Communications.
