Dear Ms. Dillon:

Americatel Corporation d/b/a 1010 123 Americatel, Ametex, Ametel and 1 800 3030 123 Americatel Collect ("Americatel") respectfully responds herein to Data Request No. 1, issued by the Tennessee Regulatory Authority ("TRA") on May 4, 2006.

Item 1. "Have the petitioners filed similar petitions or notices in other states? If so, provide a listing of states and action taken."

Americatel filed similar petitions or notices in numerous states. The identity of those states and the status of such filings, as of May 9, 2006, are set forth in Attachment A hereto.

Item 2. "Have the petitioners filed a similar petition with the FCC or other federal agency? If so, list any action taken and the associated file(s) or document number(s). If a schedule to complete the review of your application has been established by any federal agency, provide such with your response."

Americatel made several filings with the FCC. The specific filings, associated file numbers and agency schedules are detailed in Attachment B hereto.

Item 3. "Provide the number of customers that Americatel Corporation d/b/a 1010 123 Americatel, Ametex, Ametel and 1 800 3030 123 Americatel Collect ("Americatel") currently has in Tennessee."

As of April 30, 2006, Americatel has 1,965 customers in Tennessee.

Item 4. "Confirm that petitioners will continue to operate under their present CCNs [Certificate of Public Convenience and Necessity] issued by the Authority and business licenses as filed with the Tennessee Secretary of State's Office."

After completion of the transfer of control, Americatel will continue to operate under its existing CCN issued by the TRA and under its business license on file with the Office of the Tennessee Secretary of State.

Item 5. "File the Stock Purchase Agreement (the "Stock Purchase Agreement") the Parties executed and/or entered into on March 23, 2006, per the Petition filed with the Authority on April 21, 2006."


