RE: Petition of Tennessee Wastewater Systems to Expand Its Service Area to Include a Portion of Montgomery County in Tennessee Known as East Montgomery Service Area (Docket No. 06-00184).

Dear Mr. Pickney:

A Petition was filed in this Docket on July 13, 2006. Subsequent to the filing, the Tennessee Regulatory Authority ("Authority") received a letter dated August 15, 2006 from the Montgomery County Mayor, Mr. Douglas Weiland, requesting that the Authority deny Tennessee Wastewater's amendment to expand its service territory to include the portion of Montgomery County known as East Montgomery. Mr. Weiland stated that Montgomery County intends to establish a Wastewater Regulatory Authority, pursuant to Tenn. Code Ann. § 68-221-601 through 68-221-618 that will benefit the interests of all county residents. A copy of Mr. Weiland's letter is enclosed.

On September 21, 2006, the Authority received a letter from Carolyn P. Bowers, County Mayor of Montgomery County, requesting that the Petition by TWS, Inc. to expand its service territory to include East Montgomery area be approved; however, maintaining that Montgomery County intends to establish a public Wastewater Regulatory Authority and that you have agreed to work with them in that regard. A copy of Ms. Bowers letter is also enclosed.

To assist the Authority in its review of Tennessee Wastewater Systems, Inc.'s (TWS) amendment to its Certificate of Convenience and Necessity to provide wastewater utility services to a portion of Montgomery County, Tennessee known as the East Montgomery Service Area, please explain in detail the specific roles both TWS and Montgomery County will have in working together to establish a Wastewater Authority in Montgomery County. In addition to the explanation, please provide the following information:

- 1. Is there a signed contract between Montgomery County and TWS? If so, please provide the Authority a copy of the contract.
- 2. Which party will contract for the construction of the system?
- 3. Which party will own the system?
- 4. Who will pay for the system that is built?
- 5. Who will operate the system?

Please provide your response no later than 2:00 P.M. on Thursday October 12, 2006 and reference Docket No. 06-00184. In accordance with TRA rules, submit either one original and thirteen (13) written copies of your response or an original and four (4) written copies and an electronic version.

In reference to the above captioned item—Docket No. 06-00184—it is Montgomery County's intent to establish a Water and Wastewater Authority, pursuant to T.C.A. 68-221-601 through 68-221-618. We therefore respectfully ask that the petition by TWS, Inc., to amend its Certificate of Convenience and Necessity (CCN) not be approved.

While Tennessee Wastewater Systems has applied to expand service to include a portion of Montgomery County known as East Montgomery, it is Montgomery County Government's desire to explore the creation of a Wastewater Regulatory Authority that is in the best interests of all county residents. As mandated by T.C.A. 68-221-604, the Montgomery County Board of Commissioners shall hold a public hearing; then, if the local legislative body determines that the public convenience and necessity require the creation of an authority, a resolution shall be approved declaring such authority.

Montgomery County is a rapidly growing community, as indicated by our 34% population increase and the overwhelming demand for building permits. We would appreciate the opportunity and time necessary to institute a public Wastewater Regulatory Authority.
