I, Sharla Dillon, being first duly sworn state as follows:

1. I am the Dockets and Records Manager of the Tennessee Regulatory Authority (“Authority” or “TRA”) and have been employed in that position since January of 2001.

2. As the Dockets and Records Manager, I am responsible for creating, updating and maintaining service lists for agenda and hearing notices. The Authority has an established procedure for providing notice to persons and entities regarding Authority Conferences and hearings before the TRA. As a mechanism for providing notice to “interested parties,” the Authority utilizes a service list and sends copies of the conference agenda by way of facsimile transmission to persons or entities on that list. The agenda for each Conference is also posted on the TRA website.

3. I followed the above described procedure in sending out copies of the agenda for the September 25, 2006 Authority Conference.

4. I have reviewed the Authority’s service list for agenda notification and that list shows that Jonathan Harlan at Aeneas Communications, LLC receives a copy of the conference

agenda each time an agenda is issued. The service list for conference agendas also includes the law firm of Farris, Mathews, Branam, Babango & Hellen, PLC with Christie Stout designated as the person at the Farris, Mathews law firm to receive TRA notices or agendas.

5. I reviewed the service list for the September 25, 2006 Authority Conference and found that Aeneas Communications, LLC and the law firm of Farris, Mathews, Branam, Bobango, Hellen & Dunlap, PLC were in the service list to receive copies of that agenda.

6. The service list confirms that a copy of the agenda for the September 25, 2006 Authority Conference was sent to and received at the fax telephone number of Mr. Harlan at Aeneas Communications, LLC on September 15, 2006 at 2:09 p.m. The service list also confirms that a copy of the agenda for the September 25, 2006 Authority Conference was sent to and received at the fax number for the Farris, Mathews law firm on September 15, 2006 at 2:15 p.m. A copy of the service list showing confirmations of receipt Aeneas Communications, LLC and the Farris, Mathews law firm is attached to my Affidavit as **Exhibit A**.

7. In addition to sending out the copy of the agenda to the service list, an electronic copy of the agenda was posted on the TRA's website on September 18, 2006 at 7:36 a.m. and was available for review by the public after that date and time.

8. I affirm that the statements contained in this affidavit are true and accurate based on my personal knowledge.

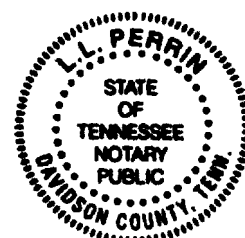
