"CORRECTED" RESPONSE OF LORETTO TELEPHONE COMPANY, INC TO THE TENNESSEE REGULATORY AUTHORITY REQUEST FOR RECIPROCAL COMPENSATION BILLING AND FINANCIAL RECORDING OF ASSOCIATED REVENUE AND EXPENSE

RESPONSE:

At the February 26, 2007 Status Conference regarding Docket No. 06-00228 - Petition of the Tennessee Rural Coalition for Suspension and Modification Pursuant to 47 U.S.C Section 251 (f) (2), the TRA requested the Coalition members to provide a response to the question of reciprocal compensation billing and financial reporting.

Loretto Telephone Company, Inc. ("Loretto") provides the following response:

"Loretto" did not bill the wireless carriers participating in Docket No. 05-00585, nor any other wireless carrier, because we were initially relying on the PMAP information. There was no usage on the PMAP for the OCN's of the following carriers involved in the Docket:

AT&T: 6010 BellSouth Mobility (Cingular): 6214

Sprint: 664 & 8459

Cellco Partnership (Verizon Wireless): 6673

Powertel (Tmobile): 7474 & 7476

There was usage on the PMAP for:

AT&T Communications Inc.: 593A Sprint Communications: 8742

However, usage on the above 2 carriers was so minor, it was not feasible to render bills for such minor usage at the interim rate.

After further investigation we realized that the PMAP database was worthless, since the two major cellphone carriers in our area, Cingular and Verizon, did not have any usage in the PMAP database. Fortunately our programmer had been capturing the wireless usage on our trunk data downloads. The summary of that usage is attached for the period from October 2004 to December 2006.

Even though "Loretto" had not rendered a bill, "Loretto" recorded reciprocal compensation revenue and expense on all the PMAP usage on all the carriers, not just the five carriers involved in the Docket. For the period from May 2005 to December 2006 the December 31, 2006 entry was as follows:
