ORDER RESUSPENDING TARIFFS THROUGH AUGUST 31, 2007

---

This matter came before the Hearing Officer for the purpose of preparing this matter for hearing, including handling preliminary matters and establishing a procedural schedule to completion. On October 10, 2006, Tennessee Wastewater Systems, Inc. ("TWS" or the "Company") filed the *Petition of Tennessee Wastewater Systems, Inc. to Amend Its Certificate of Convenience and Necessity to Correct the Rate Structure for Commercial Resort Properties* ("Petition") in which the Company seeks to reclassify certain properties from a residential to a commercial classification, which would effectively result in an increase in rates for those customers who are reclassified. The *Petition* states that certain commercial resort properties "were improperly classified as residential developments."<sup>1</sup> On March 8, 2007, TWS filed several revised tariffs containing effective dates of May 1, 2007.

On April 5, 2007, the Hearing Officer entered an *Order Continuing Hearing, Suspending Tariffs, Directing Responses to Petitions to Intervene and Setting a Status Conference* in which the effective dates of the proposed tariffs were suspended through July 1, 2007. Because the Hearing and determination of TWS's proposed increase, change or alteration in tariffs cannot be completed


prior to the effective dates of the tariffs, the Hearing Officer hereby re-suspends the effectiveness of the tariffs through August 31, 2007.
