Dear Customer-

Tennessee Wastewater Systems, Inc. provides sewer service to your resort cabin. For some time, you have been assessed the residential rate for your cabin. According to our tariff on file with the Tennessee Regulatory Authority, however, the appropriate service classification for your resort cabin is the commercial rate.

Effective with the monthly service period beginning on April 1, 2007, your monthly sewer bill will reflect your correct rate classification. Your rate will be based on the waste stream flow from your cabin. The minimum monthly sewer bill will be \$75.93/month for a waste stream flow up to 300 gallons per day (gpd). The following usage chart applies for graduated usage:
